DELEGATIONS Ray Kudwa from Mastodon Township asked the board if the township can name roads and was told that the road commission and 911 will work with the township to do that.

Kudwa had questions about the board's policy regarding sharing in the cost of crushing gravel with a township. Kudwa said Mastodon Township wants to be on the list for the next five years but they missed the deadline. Commissioner Germic said he is not in favor of changing the policy and making exceptions.

He asked Kudwa to put his request in writing to the Superintendent.

CENTERLINE PAINTING Commissioner Schmidt said he has gotten calls from residents in the Robinson Lake area asking if the Forest Highway 16 centerline can be painted. Superintendent Tomasoski will have more information at a future meeting.

CRACK FILL MATERIAL Commissioner Schmidt asked if the crack fill material could be bid out earlier so that we have it when the summer temps are ready to start working. Tomasoski said that can be a February agenda item.

ATTORNEY'S REPORT Attorney Tousignant had nothing to report.

COMMISSIONERS' COMMENTS Commissioner Sabol said the new trucks are really nice and that they should be kept washed, and clean inside.

Commissioner Schmidt asked for a list of road projects done in the last year.

Commissioner Battan asked if we will be crushing gravel this year. Tomasoski said he will be looking at quantities on hand.

Commissioner Germic said he would like to see the committees more active, especially the equipment committee. He said he will be looking to the committees for input before the board makes decisions.
