- 2. The coordinator named above is to be held responsible for the accountability and will maintain the necessary records for all surplus property obtained for public purposes until relieved from accountability by the Stare and/or Federal authorities.
- 3. That the money is available to pay service charges for surplus property obtained.
- 4. That the coordinator is further hereby authorized to direct payment of service charges for surplus property to complete all transactions.
