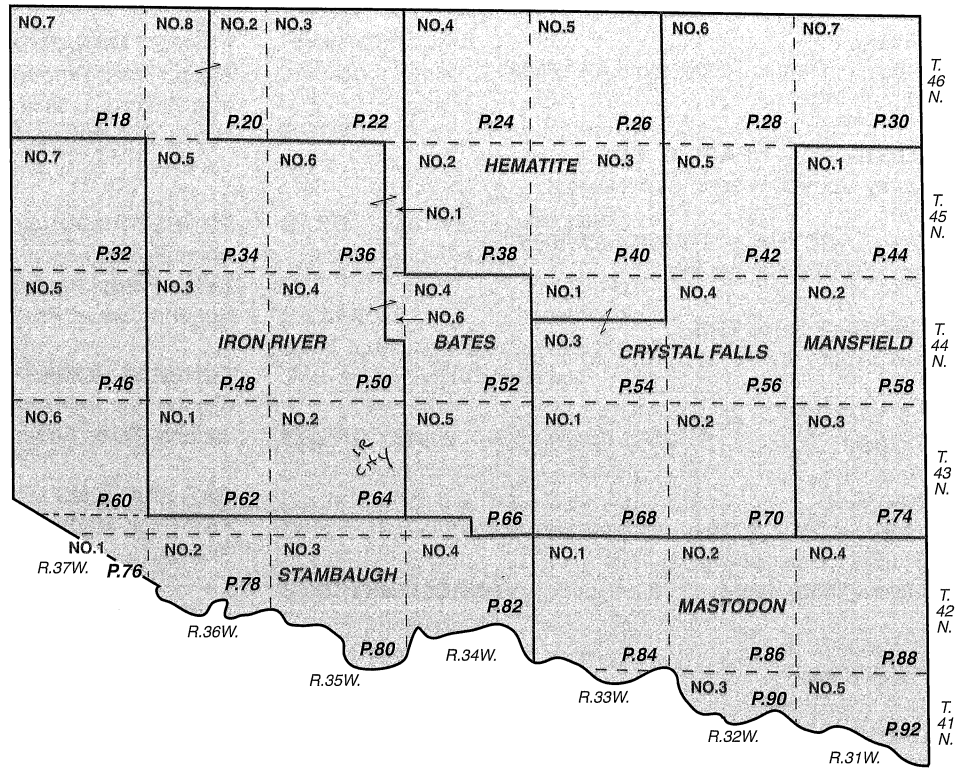


IRON COUNTY, MICHIGAN
