FUEL TANK BIDS DISCUSSION


Three bids were received and summarized in a schedule by Superintendent/Manager Tomasoski and he presented the bids and asked Great Lakes Petroleum, Inc, whom had the low bid, to answer questions from the Board. With questions addressed and procedures explained for installation there was no further discussion.

Commissioner Schmidt made the motion to award the bid to Great Lakes Petroleum, Inc. for two underground systems, one at Oss and one at Iron River garage to include the additional equipment. Support came from Commissioner Battan.


Roll call vote: Ayes- Germic, Schmidt, Battan and Frailing. Note that Commissioner Clisch supported this via Zoom.
