IRON COUNTY ROAD COMMISSION SEASONAL ROAD RESTRICTIONS POLICY

"NO LOAD OVER 5 TON" ROAD RESTRICTIONS SHALL BE IN PLACE ON ALL ROADS WITHIN THE COUNTY SYSTEM EXCEPT for the following roads that shall be classified as EXEMPT under "NO LOAD" limits: Class A Roads

- ◆ FH-16 (US 2 north to the Houghton county line)
- ♦ Beechwood Store Road (US 2 to Basswood Road)
- ◆ Osterlund Road (M 189 to Ski Brule)
- ◆ County Road 657(Gibbs City Road) -(US 2 to Gibbs West)
- ◆ Old Atkinson and Gendron Roads (CR 657 to prison camp).
- ♦ County Road 424
- Industrial Park Road (including Old US 141 from US 141 in section 22 to Industrial Park Road) and Warner Mine Road north 0.4 miles from Industrial Park Road
- ♦ Corral Road
- ◆ Camp 5 Road (Dickinson county line to Lower Dam Road)
- ◆ Lower Dam Road (Camp 5 Road west 0.32 mile)
- ◆ CR 643 Bates Amasa Road

ROADS EXEMPT FROM "NO LOAD" RESTRICTIONS SHALL STILL HAVE STATE SEASONAL LOAD RESTRICTIONS ENFORCED ON THEM.

Also **EXEMPT** from county restrictions shall be the following **vehicles**:

- **♦ EMERGENCY VEHICLES**
- ◆ SCHOOL BUSES
- ◆ ROAD COMMISSION VEHICLES INVOLVED IN ROAD REPAIR WORK
- MILK & POTATO HAULERS WITH PROPERLY EXECUTED PERMITS FROM THE IRON COUNTY ROAD COMMISSION SUPERINTENDENT

Road restrictions and the termination of such restrictions shall be effective upon delivery of written notice to the Iron County Sheriff department and the posting and/or unposting of road signs. Local news media shall be furnished with written notice of impending road restrictions in a timely manner, whenever possible.

FINES FOR VEHICLES OPERATING ABOVE THE REDUCED MAXIMUM WEIGHTS FOR SEASONAL ROAD RESTRICTIONS DETAILED IN MCL 257.722 SHALL BE IN ACCORDANCE WITH THE FINE SCHEDULE OF THE MICHIGAN MOTOR VEHICLE CODE MCL 257.724.

SPECIAL HAUL PERMITS MAY BE ISSUED IN EXTENUATING CIRCUMSTANCES. Written permits issued by the superintendent must be received prior to any hauling and must be carried in the vehicle to which it was issued. The following conditions must be met before approval will be considered:

- 1. Two (2) days advance notice to the ICRC shall be required before a permit will be issued.
- 2. Permission to haul requests must be directly addressed to the superintendent, only, either verbally or in writing.
- 3. Requests for hauling permits must be received and considered by the superintendent **only during regular business hours**Monday through Friday, 8 a.m. to 4 p.m.
- 4. A permit fee in the amount of \$35.00 shall be assessed and must be paid in full prior to the issuance of the approved permit.
- 5. In some cases, hauling approval may require the posting of a performance bond, based upon the judgment of the superintendent.

RESTITUTION WILL BE SOUGHT AGAINST ANY AND ALL VIOLATORS THROUGH PROPER LEGAL CHANNELS.

The following individuals are hereby duly authorized agents of the Iron County Road Commission, and as such, may stop and inspect those vehicles which they deem to be in violation of current load limits: **superintendent, engineer, general foreman, foremen, and the night patrol persons.**

The superintendent of the Iron County Road Commission shall be designated as the only contact person on road restriction issues. Any matters pertaining to road restrictions shall be directed solely to the superintendent.

The interpretation of this policy shall be strictly the sole responsibility of the superintendent of the Iron County Road Commission.
