# SUPERINTENDENT'S REPORT

Interim Supr. Toivonen then reviewed his report:

Fuel Tank Update- Trimedia was here on March 3, 2023, to review EPA regulations and conduct a site tour. Will have a draft of the SPCC plan by the end of the week.

Gravel- Northern Crushing and Screening plans to mobilize in June to do crushing for MoCorp and then go on to Oss.

Local Roads- Interim Supr. Toivonen met with Local Twp. Supervisors. Stambaugh-University agreement has been signed and the 50% deposit has been received. Bates-Helgemo Rd. is a go. Andreski Plat was cancelled by the Twp. (ICRC will still be scarifying) Long Lake and Berhardt are still on the bubble and Mastodon will probably be doing chipseal on McClaren. Due to budgetary constraints, the Road Commission will not be doing chip seal this year, and there will be no local matches made to townships for chip seal requests.

Equipment- After further discussion with Dean, the opinion is that the older trucks are too far gone/ too old to feasibly reframe them and therefore recommends looking for used trucks to start an upgrade to the fleet.

Radio-Contact information from a vendor at the CRA Road Show was given to Dean. He obtained some pricing information and as they are over \$2700.00 each, we will continue to research and look to budget for some in 2024.

Employment- Reviewed the summer college applications and will be calling them this week. April 10 was the deadline for the HEOP position, and Brad is looking at next week to review and compile applicants. An advertisement was also put into the Reporter for the vacant mechanic position with a deadline of May 8<sup>th</sup>. Kevin has completed and is certified in Office Tech Training, Field Manager and both he and Brad will be attending the Paser class 2 in Houghton on April 12.

Bridges- Idlewild: Application for funding sent to MDOT 4/3/23. Funding is estimated to be short 316 million dollars for bridge funding Statewide.

FFH-16: Interim Supr. Toivonen spoke with both Brian Hewitt (USFS/ Ottawa District) and Henry Schienbeck (Great Lakes Timber Assoc. Lobbyist) to assure them we are doing everything we can to get load restrictions removed. Schienbeck said he would voice to Legislature about getting some funding help. Resort Drive: Discussed abandonment of bridge and will be reaching out to MDOT on it.

Seasonal Weight Restrictions are still on. Permit requests have slowed. Roads are very soft, and frost is coming out of the roads quickly.

Interim Supr. Toivonen additionally provided:

We are in the process of updating the Road Commission website through North Country Website Design, after which we will be able to post to the website ourselves.

A.E.D Units- Three units were ordered from Superior Life Services out of Marquette with a back-order timeline of 12 weeks. When Tom Bucek is back in the area, we will get CPR and AED training scheduled.

Interim Supr. Toivonen recognized and thanked the Road Commission crews for their hard work and efforts the last few weeks.

# **USED PLOW TRUCK**

Interim Superintendent Toivonen and Shop Foreman Stolberg discussed the 2009 Cummins for sale from Oma Township. The truck having a front plow, a front mounted wing, and no underbody plow greatly limits who can operate it and where it can be used. The cost of attempting to modify the truck to how we would want it, on top of the purchase price, does not make financial sense compared to potentially buying a used truck already set up closer to how we would use it.

A motion by Commissioner Battan, supported by Schmidt, to not purchase the used truck for sale from Oma Township.

# **MERS EOY 2022**

Finance Director Johnson presented the End of Year Statement of Fiduciary Net Position from MERS as informational: 2022 had an overall net decrease of \$551,890.04. However, when breaking it down quarterly instead, the first three quarters experienced a loss of \$1,112,880.40 with the fourth quarter gaining back \$560,990.36. Additionally, the Road Commission does not qualify for the Pension Grant Program advertised by the State. We were 62.6% funded as of last year and qualified applicants must be under 60%. Chairman Frailing asked that some research be done regarding the rate of return we have received up to now. Additionally, the Board requested a meeting with MERS to get some more information and ask questions.

# FFH-16 BRIDGES-REHABILITATION ENGINEERING PROPOSALS

Engineering bids from GEI Consultants and Ayers Associates were received and presented for the Rehabilitation of the FH-16 N & S Branch Paint River Bridges.

Interim Supr. Toivonen recommended Ayers Associates, with the low bid of \$22,700 (11,350 each bridge). He added that Ayres also does our annual bridge inspections and is familiar with them.

A motion by Commissioner Schmidt, supported by Battan, to award the FFH-16 bridges engineering bid to Avers Associates for \$22,700.

Corey Thompson, PE; CBI from Ayers was in the audience for any questions. Commissioner Schmidt asked about a timeline for construction. Corey anticipates design by fall of 2023, bids over winter and construction in 2024.

#### Schedule

The enclosed bar chart timeline provides a detailed progress schedule for each phase of work to bid the project in January 2024. Note that our schedule assumes 90 days for USACE/EGLE Permit Application review. GEI has available and capable staff to complete this work and we do not anticipate any of our scheduled workloads will present a conflict during the design of this project. We are prepared to begin work within two weeks of when a notice-to-proceed is issued. Our attached schedule assumes that a notice-to-proceed will be issued during the week of April 24, 2023.

## Estimated Fee, Reimbursable Expenses, and Conditions of Service

The proposed scope of services outlined above will be performed in accordance with the enclosed Standard Professional Services Agreement, or other mutually agreeable terms. We propose to complete these services for a lump sum fee of \$39,450.00. A breakdown of the estimated fee and reimbursable expenses per phase for each bridge is detailed in the table below.
