Brad Toivonen, Finance Director Michelle Johnson, HR-PR Administrator Patti Leonoff, Foremen Dean Stolberg, Iron County Commissioner Ean Bruette, Dave Smith, Mastodon Twp., and Attorney Mark Tousignant. Additionally, Bruce Moore, Bethany Leiter, and Jake Stedman from Highline were present, as well as Brian Schiavo, GEI Consultants, and Ryan Dennis, Iron County resident.

# SUPERINTENDENT'S REPORT

Interim Supr. Tolvonen reviewed his report:

Fuel Update- Oss fuel delivery on 3/28/24. We will be waiting until after May 1<sup>st</sup> to order fuel for IR as that is when the terminals switch from winter to summer gas.

Salt- IR received another 500 tons of salt 3/28-4/2/24; Escanaba docks are unloading salt from the docks.

Iron River Shop-A request for estimates was sent out to two companies in Iron Mountain for roof repairs and building upgrades needed.

Oss Garage-Wall lights in wash bay are being changed out for LED lighting.

# Primary Roads:

Phase 6-Bids received with Payne & Dolan coming in with the low bid of \$467,782. This is 5.7% below the Engineer's Estimate-a \$28,000 bid savings. This, together with the savings from the Brule Mountain project, might be able to go toward a County wide MDOT letting primary road system pavement marking project for 2025.

Hagerman Lake PH2-2026-Let Steve Purri, CRA, know we will be looking to do a federal aid buyout.

Tunnel Vision- Will be getting estimates for culvert linings for FFH-16 for 2025.

FHWA-ER Program 2023 Flooding-The Preliminary Engineering was not originally included in the submission for Smokey Lake Rd. The \$80,712 was added, submitted, and has received approval from FHWA. It will be covered 80/20. UPEA should be completing survey work this week and begin rough designing in the next couple of weeks for all sites.

## Local Roads:

2024 Local Projects-Received all agreements except Hematite Township for Townline Rd.

Legislative Appropriations-Ernie, Dan and Brad met with Senator McBroom and Representative Markkanen in Lansing last week at the Legislative Banquet and were told there is not money available to help the six counties with flood damages.

Section 19 Funding-Nothing new but will be attending the Iron County Emergency Management Teams meeting next week.

Equipment: Delivery still expected in July for both chassis. The Board had previously requested quotes for painting the quads, when the new boxes were installed this spring; the bids were received and came in between 8-10,000 per truck (cabs only) as an estimate for paint only, no body work, and without physically seeing the trucks. Dean has been working on buffing them and Chairman Schmidt requested Commissioner Battan from the Equipment Committee go to the garage and see how the buffing turned out, with the possibility of painting them in-house.

GPS Tracking-Feedback from other road commissions has been coming in on different companies that provide GPS tracking, with the intent of using it for insurance and safety issues. A meeting with Samsara is scheduled for April 10.

Employment: HEOP-Application review was April 8; once the rankings are compiled, Michelle will be setting up interviews for April 15. MDOT night patrol has been extended one week. The Mechanic interviews were conducted, and the job offer was accepted. Nine applications for summer help were received and assigned to the shops. The HR-PR Administrator/Asst. Finance Dir. Position has been posted in the Reporter, Chamber website and the ICRC website, with a deadline of May 2<sup>nd</sup>.

## Bridges:

Idlewild Rd.-Fortune Cr.-Bridge program application submitted on March 28<sup>th</sup> for 2027 construction. When beginning design work, UPEA determined the bridge span could be less than originally thought, which would keep this bridge in the smaller bridge category within the bridge program, increasing the chances of receiving funding. The design plans have gone as far as they can until funding is determined.

FH-16 N & S. Branches Paint River-Bridge program applications submitted March 28th for 2027 construction.

Wild Rivers-Iron River Culvert Crossing- Working with Bette Premo in submitting another grant.

Biennial Bridge Inspections-One bid received: agenda item.

Winslow Lk. Rd.- Winslow Creek-There have been many phone calls about the 15-ton load rating of the bridge, including a logging company inquiring about putting a structure over the existing bridge in hopes log trucks could then cross. This brings concerns not only about funding, but also engineering, damaging what is currently there, insurance and liability. There is very little bridge funding in the State and there is little the road commission can do at this time.

#### Miscellaneous:

MDOT work items-Brad, Michelle, and Andy Illieff, MDOT, to discuss possibility of a new salt shed in Iron River in 2026.

Regional Task Force- Meeting on April 11, at which the County-wide pavement marking project will be brought up for voting and approval.

MCRCSIP- Five-year building appraisals will be taking place. We will be taking the opportunity to ask questions about the building contents and insurance. Safety training will be done during the week of May 6<sup>th</sup>.

Treeline Dr.-Received abandonment request on April 2<sup>nd</sup>; MCRCSIP is walking us through the process. In review of the petition and request, there were some questions and we met with Bill Henn on April 8<sup>th</sup>. Agenda item.

County Road Assoc. -CRA put out a second media release, highlighting a mileage-based user fee as one possible solution for Michigan's severely underfunded road and bridge network.

Seasonal Weight Restrictions: Restrictions are still on. The earliest they have ever been taken off is April 22<sup>nd</sup> and there are no signs of them coming off before then this year.

Fiber Optic: Approved the first permit, for New Bristol Rd., with four more permits being received for the Crystal Falls Twp. area. Seasonal road restrictions will temporarily affect some of the permitting process. Discussion is ongoing with JSI on the permitting and inspections for their fiber optic project; seasonal road restrictions will affect them as well.

County-Wide Road Millage-Chairman Schmidt and Interim Supt. Toivonen will be attending the County Board meeting today at 4:00 p.m. for the approval of the ballot language.

Fahrner Emulsion Demo-Fahrner is willing to do a test strip at their cost of incorporating emulsion into a gravel road for dust control. More details to come.

Drain Commissioner- Chairman Schmidt and Interim Supt. Toivonen will be attending the County Board meeting today at 4:00 p.m. to discuss moving drain commission duties back to the County. Due to the low run-off from this winter, there is a possibility of putting boards into dams earlier this year.

# HIGHLINE FIBER OPTIC 2024 UPDATE

Bruce Moore, Bethany Leiter, and Jake Stedman made a presentation to the Board with goals and expectations for fiber optic internet service within Iron County for 2024 as well as to entertain questions. Points of Interest:

- Highline won a 180-million-dollar grant, of which 162 million will be spent in the U.P.
- 1,600 miles of fiber will be put into the U.P; 439 miles of which will be in Iron County, providing access to 5,382 households.
- Lessons learned from earlier projects in other counties is that there were mistakes made out in the field by contractors; Bruce assures that these have been corrected and will not be an issue going forward.
- GEI has been contracted as a Third-Party Inspector for fiber optic installation in Iron County done by AEG. Highline has also hired additional personnel to oversee the work.
- Highline and the Road Commission will continue to work together to streamline the permitting process
  and get the fiber laid as correctly and efficiently as possible. The more accurate the permits, the better
  the job will go.

# SET DATE/ TIME FOR PUBLIC HEARING: PARTIAL ABANDONMENT OF TREELINE DR.

Following discussion about the time constraints for the hearing and required notices, Interim Supt. Toivonen recommended May 14, 2024, at 10:00 a.m., following the regular meeting.

- 1. Townships should not assume that their underground infrastructure (Water/Sewer lines) is protected by permits issued by the road commission.
- 2. All Municipalities within the County should receive digital as-built drawings of the lines when the install is complete.

# **COMMISSIONERS COMMENTS**

Commissioner Schmidt shared an interesting product they saw at the Road Show in Lansing last month that is intended to be used on gravel roads. Brad may reach out to the company about getting a test strip done in Iron County.

# RE: Legal Boundary Determination Survey & Location Map of Buildings and Improvements for design of New Salt Shed

- ➤ Legal Boundary Survey We will locate Section, quarter, sixteenth, subdivision and existing property controlling monuments to survey the parcel of land. New monuments will be set where monuments were not found. A paper copy of the Certificate of Survey showing the legal boundary of the parcels will be signed and sealed by a Michigan Professional Land Surveyor and provided to the client at the end of the survey project.
