

**2026 Reorganizational Meeting**

1. Clerk Michelle Johnson called the Reorganizational Meeting of the Iron County Road Commissioners of Iron County to order at 9:00 a.m. in the Road Commission office at 800 W. Franklin Street, Iron River, Michigan.
2. Pledge of Allegiance and roll call.  
Commissioners Chuck Battan, Ron Frailing, Ernie Schmidt, Jim Chiak and Dan Germic were present. Superintendent/Manager Brad Toivonen was also in attendance.
3. Clerk Johnson called three times for nominations for Chairman for 2026.  
The first nomination was for Commissioner Ernie Schmidt, made by Commissioner Cihak with support from Frailing; there were no other nominations.  
Voice vote, all in favor. A majority vote was reached on the Schmidt nomination for Chairman.

Clerk Johnson declared Commissioner Ermie Schmidt as Chairman of the Board of County Road Commissioners for Iron County for 2026.

4. Clerk Johnson called three times for nominations for Vice Chairman for 2026.  
The first nomination was for Commissioner Ron Frailing, made by Commissioner Schmidt with support from Germic; there were no other nominations.  
Voice vote, all in favor. A majority vote was reached on the Frailing nomination for Vice Chairman.

Clerk Johnson declared Commissioner Ron Frailing as Vice Chairman of the Board of County Road Commissioners for 2026.

Voice vote, all in favor. Motion carried.


6. Committee assignments:
